 members and licence holders worldwide.
- AAT is an Ofqual licenced Awarding and Apprenticeship Organisation offering globally recognised qualifications and apprenticeships in Bookkeeping, and Accountancy.
- Recognised by International and Asian Accounting Federations; IFAC, CAPA, and AFA.



- The AAT is based at Canary Wharf, London and has 580 training and assessment centres across the UK.
- With representation in the rest of the world including the Middle East, Malaysia, Botswana and South Africa.


