
Just 57% of countries worldwide report having professional teaching standards and policies for TVET and skills.\*

### Global Challenges: Poor workforce considerations

#### UNESCO TVET report stated that


- In terms of TVET staff, just 57% of States reported having policies that cover teachers.
- Most of these are not dedicated TVET teacher policies, but often civil-service policies applying to all civil servants or overall teacher policies.
- TVET teacher policies and strategies mainly addressed initial teacher education (55%); teaching-staff recruitment and retention (51%); and career structure and path (49%).
- Less than half of the States (48%) reported the majority of their TVET teachers (>80%) had the minimum level of qualifications required by law.

Everything we do at ETF is about supporting the skills sector workforce on their professional journey to provide transformational opportunities for learners aged 14 and over.



Since 2012, over 350,000 teachers, trainers, assessors, mentors, governors and leaders have come to the ETF. This is comprised of:


- 23,000+ individual professional members

Excellence is also about adaptability: what works for one learner might not for another.


Learning from peers from across the system is key to it becoming sustainable and self-improving. Learning can happen informally through peer connections, shared learnings and community.

These standards are globally agnostic and adaptable to different types of institutions. At the heart, standards create consistency in quality.




## 2. Case study: Specialist Status – Sustainability in Education

The bridge from skills to employers: delegates from Siemens, EKC Group, and colleges and universities across the UK have all enrolled in the ESD programme.


